

## **Terms and Provisions of Registration for Masterclasses**

### ***Photography Expertise Expected for Masterclasses***

- i. To maximize the benefits from all Masterclasses it will assist greatly if you are familiar with all functions on your camera and be able to use these functions without frequent reference to the camera manual. Ensure you pack the manual (just in case you need to make some new found adjustments to camera settings!).
- ii. You will also learn more if you have a working knowledge of Photoshop, Lightroom or similar software and be reasonably competent in the use of this on your own computer. Please take along your own laptop.
- iii. The Masterclasses are designed to cater for photographers having a broad range of skills and knowledge, from beginner photographers to professionals. Significant improvements will be seen in your work as you "look over the shoulder" of a Master of Photography at work, frequently working on one of your own images.

### ***Minimum Number of Registrations***

- i. All Masterclasses are arranged on the basis of having a minimum of twelve participants. If we are forced to cancel due to inadequate numbers, you will receive a full refund of any fees paid. We will not be responsible for any other expenses you might incur in respect of air or other travel, accommodation, etc., unless the costs of such items are specifically included in the Masterclass fee.

### ***Insurance***

- i. For Masterclasses that involve air travel, accommodation, and other such expenses we advise that you obtain suitable travel insurance to cover unforeseen circumstances.
- ii. Camera and other photographic equipment insurance is the sole responsibility of each participant.

- ii. If your registration is cancelled less than twenty days before commencement of the Masterclass, any fees paid will not be refunded. If, however you provide a replacement participant to fill the vacant place, any fees paid by you will be refunded. No refunds will be made for unused portions or services of the Masterclass for any reason. Cancellation fees are not transferable.
- iii. Upon registering and paying the requisite fee on-line you will automatically receive a PayPal-generated receipt. Please print and retain a copy of this receipt as evidence of (i) your payment (ii) acceptance of registration for the event and (iii) to forward to us in the event you seek a refund.
- iv. Registrations are allocated strictly in the order of payments received.
- v. If the Masterclass or Workshop is cancelled by us you will receive a full refund of the fees paid by you.
- vi. We will make every effort to adhere to the advertised schedule and content but we retain the right to change this due to weather or unforeseen circumstances related to the normal vagaries of outdoor photography.

## ***Pre-dawn and Sunset Shoots & Potential for Accidents or Injury***

- i. On occasions pre-dawn and sunset/post-sunset shoots will form part of the Masterclass. These are optional activities, but you will likely capture your better images during these shoots. There may be some moderately tasking walking and “clambering” over rocks, sand dunes, reefs etc., to reach certain desirable locations. Please consider these activities in relation to your physical abilities and should you have any medical condition that you consider might prevent you from undertaking such activities, please discuss this with us before registering.

- ii. During Masterclasses, held in more remote locations, (e.g. The Kimberley, Karijini National Park, etc.), there is the risk of accident or illness occurring without access to immediate or timely medical treatment facilities. Please note, your registration for such Masterclasses acknowledges your acceptance that such risks cannot be eliminated without jeopardizing the essential qualities of the Masterclass. Accordingly, in consideration of, and as part payment for the right to participate in such Masterclasses and other related activities and services arranged for you, by Denis Glennon and/or Tony Hewitt, you assume all such risks, and to the fullest extent permitted by law you hereby release Denis Glennon and/or Tony Hewitt from any and all liability, actions, causes of actions, claims, and demands of every kind and nature, howsoever caused, which may arise out of, or in connection with, such Masterclasses
- iii. Your payment for registration evidences your acceptance of these terms and provisions and serves as a release and assumption of risk by you, your heirs, executors and administrators. - iv. Where pre-dawn shoots form part of the Masterclass start times are dependent upon sunrise time, thus schedules set for departure will be adhered to as closely as possible. Please bring suitable clothing and footwear, sun cream, hat and sunglasses.
